Anti-Nutritional factor

Introduction

- Anti-Nutritional factors are those one generated from natural plant feeds stuffs exerting inimical i.e. adverse effect.
- It is also a naturally occurring substances in plant materials and greatly influences a metabolic path way.
- Most of the ANF's are heat labile.
- The effects are inhibition of growth, decrease in food conversion efficiency, pancreatic hypertrophy, liver damage and other pathological damages.

Classification of Anti-Nutritional factors

- Based on nutrients affected and biological response produced in fish, the toxic factors classified as follows:
- Substances depressing digestion (or) mtabolic utilization are protease inhibitors, lectins (Haemagglutinins), saponins, polyphenolic compounds (Tannins)
- 2. Substances reducing the solubility of nutrients are phytic acids, oxalic acids, glucosinolates, gossypols

- 3. Substances which inactivating vitamins and hormones (Antivitamin A, D, E, K and phyridoxine
- 4. Mimosine
- 5. Cyanogens
- 6. Moulds and toxins
- 7. Bacterial infection (salmonella contamination and mycobacteriosis)
- 8. Bacterial toxins (Botulism)
- Chemical contaminants pesticides, herbicides, heavy metals, volatile N- nitrosamines
- 10. Peroxides

Protease Inhibitors

- Most well known is Trypsin Inhibitors.
- Trypsin inhibitor occurring in raw legume seeds, particularly soybean.
- Trypsin inhibitors were first described in soybean, but are also known to be present in groundnut and most other leguminous seeds.
- The degree of deactivation of the toxin depends upon the applied temperature, duration of heating, particle size and moisture conditions.

- Soyabean trypsin inhibitors are totally deactivated by moist heat at 100°C for 15-20 minutes.
- Overnight soaking or germination of beans, while bringing about improvement in their nutritive value, does not destroy the trypsin inhibitors.

Lectins (Haemagglutinins)

- Haemagglutinins, or lectins, are proteins that possess a specific affinity for sugar molecules.
 As the name implies, they cause agglutination of red blood cells.
- These toxins, which cause red blood cells to agglutinate, are present in almost all legume seeds.
- The potency of the toxin, however, varies from species to species, with those of *Phaseolus* vulgaris among the most potent.

- Phyto-haemagglutinins are also heat labile, but care should be taken to ensure that adequate heat is applied.
- It is found in seeds of higher plants, tubers (rice, wheat, potato, ground nut oil cake, kidney bean).
- Lectins reduces absorption of nutrients in the gut and cause internal hemorrhages and growth.
- It is heat labile; cooking or autoclaving is the method used to remove this substance.

Saponins

- These significant characteristics is exhibited by saponins. They are, bitter taste, forming in aqueous solution, haemolysis of RBC.
- Effects excess salivation, increased respiration – haemolysis, damage to liver and kidney
- Examples are soyabean, mung bean, jack bean, alfaalfa.
- Soaking in water for 24 hrs will eliminate this substance

Tannins

- It is a polyphenolic compounds and same effects as saponins
- Soaking and cooking is the method to remove this substances.
- It is found in sorghum, mustard seed and rape seed.

Phytic Acid (Phytates)

- Plant which are rich in proteins and also rich phytates.
- Phytates are salts of phytic acid. It occurs in plants.
- Phytates form complexes with transitional nutritional elements (Zn, Fe, Mn) and make insoluble in intestinal tract.
- Addition of phytase enzyme externally in the feed may counter act the toxic effect. Eg. Soyabean, sesame, rape seed meal

Oxalic Acid (Oxalate)

- Both in plants and animals, oxalic acid (oxalates) found in free and salt forms.
- Eg. Beet, spinach etc.
- Water soaking in 24 hrs will reduce the oxalic acid content

Glucosinolates

- It is responsible for pungent flavour found in family cruciferae i.e. Brassica sp, which include mustard seed, rape seed and cabbage
- It depresses the thyroid hormone
- Soaking in water or cooking will reduce this content
