26 The kinetics of complex reactions

26.1 The rate laws of chain reactions

The thermal decomposition of acetaldehyde $CH_3CHO(g) \rightarrow CH_4(g) + CO(g)$ $v = k[CH_3CHO]^{3/2}$ 26.1.1 Initiation: $CH_3CHO \rightarrow CH_3 + CHO$ $v = k_i[CH_3CHO]$ Propagation: $CH_3CHO + CH_3 \rightarrow CH_4 + CH_3CO$ k_p Propagation: $CH_3CO \rightarrow CH_3 + CO$ k_p Termination: $CH_3 + CH_3 \rightarrow CH_3CH_3$ k_t

The net rates of change of the intermediates are:

$$\frac{d[CH_3]}{dt} = k_i [CH_3CHO] - k_p [CH_3] [CH_3CHO] + k_p [CH_3CO] - 2k_t [CH_3]^2$$

$$\frac{d[CH_3CO]}{dt} = k_p [CH_3] [CH_3CHO] - k_p [CH_3CO]$$
Applying the steady state approximation to the above two equations
$$0 = k_i [CH_3CHO] - k_p [CH_3] [CH_3CHO] + k_p [CH_3CO] - 2k_t [CH_3]^2$$

$$0 = k_p [CH_3] [CH_3CHO] - k_p [CH_3CO]$$

The sum of the above two equations is: $k_i[CH_3CHO] - 2k_t[CH_3]^2 = 0$

thus the steady state concentration of ['CH₃] is:

$$[CH_3] = \left(\frac{k_i}{2k_t}\right)^{1/2} [CH_3CHO]^{1/2}$$

The rate of formation of CH₄ is:

$$\frac{d[CH_4]}{dt} = k_p[CH_3][CH_3CHO] = k_p \left(\frac{k_i}{2k_t}\right)^{1/2} [CH_3CHO]^{3/2}$$

Equation 26.1.2 is in agreement with the three-halves order observed experimentally.

We have discussed earlier that hydrogen-bromine reaction has complicated rate law rather than the second order reaction as anticipated. Now we examine why

 $H_2(g) + Br_2(g) \rightarrow 2HBr(g)$

Yield

$$v = \frac{k[H_2][Br_2]^{3/2}}{[Br_2] + k'[HBr]}$$

The following mechanism has been proposed to account for the above rate law.

Initiation:	$Br_2 + M \rightarrow Br + Br + M$	$k_{ m i}$
Propagation:	$Br' + H_2 \rightarrow HBr + H'$	k_{p1}
	$H^{\cdot} + Br_2 \rightarrow HBr + Br^{\cdot}$	k_{p2}
Retardation:	$H^{\cdot} + HBr \rightarrow H_2 + Br^{\cdot}$	$k_{ m r}$
Termination:	$Br + Br + M \rightarrow Br_2 + M^*$	$k_{ m t}$

The net rates of formation of the two intermediates are

$$\frac{d[H]}{dt} = k_{p1}[Br][H_2] - k_{p2}[H][Br_2] - k_r[H][HBr]$$

$$\frac{d[Br]}{dt} = 2k_i[Br_2][M] - k_{p1}[Br][H_2] + k_{p2}[H][Br_2] + k_r[H][HBr] - 2k_t[Br]^2[M]$$

The steady-state concentrations of the above two intermediates can be obtained by solving the following two equations:

$$k_{p1}[Br][H_{2}] - k_{p2}[H][Br_{2}] - k_{r}[H][HBr] = 0$$

$$2k_{i}[Br_{2}][M] - k_{p1}[Br][H_{2}] + k_{p2}[H][Br_{2}] + k_{r}[H][HBr] - 2k_{t}[Br]^{2}[M] = 0$$

$$[Br] = \left(\frac{k_i}{k_t}\right)^{1/2} [Br_2]^{1/2}$$
$$[H] = \frac{k_{p1}(k_i/k_t)^{1/2} [H_2] [Br_2]^{1/2}}{k_{p2} [Br_2] + k_r [HBr]}$$

substitute the above results to the rate law of [HBr]

$$\frac{d[HBr]}{dt} = k_{p1}[Br][H_2] + k_{p2}[H][Br_2] - k_r[H][HBr]$$
$$\frac{d[HBr]}{dt} = \frac{2k_{p1}(k_i/k_t)^{1/2}[H_2][Br_2]^{3/2}}{[Br_2] + (k_r/k_{p2})[HBr]}$$

Equation 26.1.4 has the same form as the empirical rate law 26.1.4, so the two empirical rate constants can be identified as

$$k = 2k_p \left(\frac{k_i}{k_t}\right)^{1/2}$$
$$k' = \frac{k_r}{k_{p2}}$$

analyzing the effects of HBr, H_2 , and Br_2 on the reaction rate based on equation 26.1.4.

26.2 Explosions

A **thermal explosion** is a very rapid reaction arising from a rapid increase of reaction rate with increasing temperature.

A **chain-branching explosion** occurs when the number of chain centres grows exponentially.

An example of both types of explosion is the following reaction $2H_2(g) + O_2(g) \rightarrow 2H_2O(g)$

Initiation:	$H_2 \longrightarrow H^{\cdot} + H^{\cdot}$		
Propagation	$H_2 + OH \rightarrow H' + H_2O$		$k_{\rm p}$
Branching:	$O_2 + H \rightarrow O + OH$	k_{b1}	
-	$O + H_2 \rightarrow OH + H$		k_{b2}
Termination	$\mathrm{H}^{\cdot} + \mathrm{Wall} \rightarrow \frac{1}{2} \mathrm{H}_2$		k_{t1}
	$H^{\cdot} + O_2 + M \rightarrow HO_2^{\cdot} + M^*$		k_{t2}



Analyzing the above reaction and show that an explosion occurs when the rate of chain branching exceeds that of chain termination.
