What is Gender?

"The process by which individuals who are born into the biological categories of 'female' or 'male' become the social categories of women and men through the acquisition of culturally defined attributes of masculinity and femininity as well as the resources and

responsibilities which are associated with

these categories".

Gender Related Definitions

Patriarchy

- A system_of male domination whereby men exercise authority over women and children.
- At the informal level it also operates at the HH level or familial relations
- This system operates through formal avenues of power such as politics, law and the state.
- It operates through production of knowledge by using men's experience and needs as the norm, while ignoring women's voices and experiences

Gender Related Definitions

Power

- The quality of social relationships which enables some individuals and groups to control the material and psychological well-being of others. Operates through various channels.
- Gender relations is about power relations

Gender Related Concepts

Gender Based Division of Labour

Society has allocated different roles, responsibilities and activities to women and men according to what is considered appropriate (central to understanding gender relations)

Gender Related Concepts

Types of Work

- a) Reproductive normally performed by women in child bearing, rearing, providing for food, fuel, fodder and other HH resources
- b) Productive involves production of goods and services for consumption and trade and has an exchange value
- c) Community involves collective community level activities such as festivals, group NR activities etc.

Gender Related Concepts

Gender Roles and Responsibilities – are extensions of division of labour. How women and men should think, act and feel according to norms and traditions and is associated with their identities

Gender Valuation of Work – refers to the values attached to different tasks and responsibilities of women and men

Gender Inequality is Sharing of World's Resources and Benefits

Women perform 2/3rd of the world's work

Women earn 1/10th of the world's income

Women are 2/3rd of the world's illiterates

Women own less than 1/100th of the world's property

Gender and Development Facts at a Glance (INDIA)

Health

- Sex ratio (females per 1,000 males) of India in 1951 was 946 and has declined to 940 in 2011. Between 0-6 years 914
- Odisha 934 (CSR), 972

Education

- 75.85% male, 54.16% female
- Of the 18 million illiterates 4 million are males and 14 million are females
- Drop out rates Class 1-V 46% boys and 56%-girls, and by class VII 46% boys and 68% girls

Gender Related Facts at a Glance (INDIA)

Employment

- Work participation rates 52% men and 22% women
- Women constitute 90% marginal workers
- 1/3rd of the HHs headed/supported by women

Violence against women

There is one dowry death every one hour and 42 minutes, one rape every 20 minutes, one molestation every 26 minutes, one criminal offence against women every 7 minutes

Constitution of India Guarantees

- Article 14: Equality before law for women
- Article 15 (1): The state not to discriminate against any citizen on grounds of religion, race, caste, sex or place of birth
- Article 15 (3): The state to make any special provision in favour of women and children, e.g maternity relief
- Article 16: Equality of opportunity for all citizens in relation to employment or appointment to the office under the state
- Article 39 (d): Equal pay for equal work for both women and men
- Article 51 (A) (e): to promote harmony and the spirit of common 'brotherhood' amongst all the people of India and to renounce practices derogatory to the
