#### De• nitions

**De• nition 1.1** Complex numbers are de• ned as ordered pairs (x, y)

Points on a complex plane. Real axis, imaginary axis, purely imaginary numbers. Real and imaginary parts of complex number. Equality of two complex numbers.

**De• nition 1.2** The sum and product of two complex numbers are de• ned as follows:

$$(x_1, y_1) + (x_2, y_2) = (x_1 + x_2, y_1 + y_2)$$
  
 $(x_1, y_1) \cdot (x_2, y_2) = (x_1x_2 - y_1y_2, x_1y_2 + x_2y_1)$ 

In the rest of the chapter use  $z, z_1, z_2, \ldots$  for complex numbers and x, y for real numbers. introduce i and z = x + iy notation.

#### **Algebraic Properties**

1. Commutativity

$$z_1 + z_2 = z_2 + z_1,$$
  $z_1 z_2 = z_2 z_1$ 

2. Associativity

$$(z_1 + z_2) + z_3 = z_1 + (z_2 + z_3),$$
  $(z_1 z_2) z_3 = z_1 (z_2 z_3)$ 

Distributive Law

$$z(z_1 + z_2) = zz_1 + zz_2$$

4. Additive and Multiplicative Indentity

$$z+0=z, \qquad z\cdot 1=z$$

5. Additive and Multiplicative Inverse

$$z^{-1} = (-x, -y)$$

#### Polar Coordinates and Euler Formula

1. Polar Form: for  $z \neq 0$ ,

$$z = r (\cos \theta + i \sin \theta)$$

where r=|z| and  $\tan\theta=y/x$ .  $\theta$  is called the argument of z. Since  $\theta+2n\pi$  is also an argument of z, the principle value of argument of z is take such that  $-\pi<\theta\leq\pi$ . For z=0 the arg z is unde• ned.

2. Euler formula: Symbollically,

$$e^{i\theta} = (\cos \theta + i \sin \theta)$$

$$\begin{array}{rcl} z_1 z_2 & = & r_1 r_2 e^{i(\theta_1 + \theta_2)} \\ \frac{z_1}{z_2} & = & \frac{r_1}{r_2} e^{i(\theta_1 - \theta_2)} \\ z^n & = & r^n e^{n\theta} \end{array}$$

#### **Roots of Complex Numbers**

Let 
$$z=re^{i\theta}$$
 then 
$$z^{1/n}=r^{1/n}\exp\left(i\left(\frac{\theta}{n}+\frac{2k\pi}{n}\right)\right)$$

There are only n distinct roots which can be given by k = 0, 1, ..., n - 1. If  $\theta$  is a principle value of arg z then  $\theta/n$  is called the principle root.

**Example 1.1** The three possible roots of 
$$\left(\frac{1+i}{\sqrt{2}}\right)^{1/3} = \left(e^{i\pi/4}\right)^{1/3}$$
 are  $e^{i\pi/12}$ ,  $e^{i\pi/12+i2\pi/3}$ 

#### Regions in Complex Plane

1.  $\epsilon - nbd$  of  $z_0$  is de• ned as a set of all points z which satisfy

$$|z-z_0|<\epsilon$$

- Deleted nbd of z<sub>0</sub> is a nbd of z<sub>0</sub> excluding point z<sub>0</sub>.
- Interior Point, Exterior Point, Boundary Point, Open set and closed set.
- 4. Domain, Region, Bounded sets, Limit Points.

#### Limits



A function f is de• ned in a deleted nbd of z<sub>0</sub>.

**De• nition 3.1** The limit of the function f(z) as  $z \to z_0$  is a number  $w_0$  if, for any given  $\epsilon > 0$  there exists a  $\delta > 0$  such that

$$|z - z_0| < \delta \Rightarrow |f(z) - w_0| < \epsilon$$
.

Example 3.1 f(z) = 5z. Show that  $\lim_{z\to z_0} f(z) = 5z_0$ .

**Example 3.2**  $f(z) = z^2$ . Show that  $\lim_{z \to z_0} f(z) = z_0^2$ .

**Example 3.3**  $f(z) = z/\bar{z}$ . Show that the limit of f does not exist as  $z \to 0$ .

 $\begin{array}{ll} \textbf{Theorem 3.1} & \textit{Let } f(z) = u(x,y) + iv(x,y) \textit{ and } w_0 = u_0 + iv_0. \lim_{z \to z_0} f(z) = w_0 \textit{ if } \\ \textit{and only if } \lim_{(x,y) \to (x_0,y_0)} u = u_0 \textit{ and } \lim_{(x,y) \to (x_0,y_0)} v = v_0. \end{array}$ 

**Example 3.4**  $f(z) = \sin z$ . Show that the  $\lim_{z \to z_0} f(z) = \sin z_0$ 

Example 3.5  $f(z) = 2x + iy^2$ . Show that the  $\lim_{z\to 2i} f(z) = 4i$ .

Theorem 3.2 If  $\lim_{z \to z_0} f(z) = w_0$  and  $\lim_{z \to z_0} F(z) = W_0$ ,  $\lim_{z \to z_0} [f(z) + F(z)] = w_0 + W_0;$   $\lim_{z \to z_0} f(z) F(z) = w_0 W_0;$   $\lim_{z \to z_0} f(z) / F(z) = \frac{w_0}{W_0} \quad W_0 \neq 0.$ 

This theorem immediately makes available the entire machinery and tools used for real analysis to be applied to complex analysis. The rules for • nding limits then can be listed as follows:



- 1.  $\lim_{z \to z_0} c = c.$
- 2.  $\lim_{z \to z_0} z^n = z_0^n$ .
- 3.  $\lim_{z \to z_0} P(z) = P(z_0)$  if P is a polynomial in z.
- 4.  $\lim_{z \to z_0} \exp(z) = \exp(z_0)$ .
- 5.  $\lim_{z \to z_0} \sin(z) = \sin z_0$ .

#### Continuity

**De• nition 3.2** A function f, de• ned in some nbd of  $z_0$  is continuous at  $z_0$  if  $\lim_{z \to z_0} f(z) = f(z_0)$ .

This de• nition clearly assumes that the function is de• ned at  $z_0$  and the limit on the LHS exists. The function f is continuous in a region if it is continuous at all points in that region.

If funtions f and g are continuous at  $z_0$  then f+g, fg and f/g ( $g(z_0) \neq 0$ ) are also continuous at  $z_0$ .

If a function f(z) = u(x, y) + iv(x, y) is continuous at  $z_0$  then the component functions u and v are also continuous at  $(x_0, y_0)$ .

#### Derivative

**De• nition 3.3** A function f, de• ned in some nbd of  $z_0$  is differentiable at  $z_0$  if

$$\lim_{z \to z_0} \frac{f(z) - f(z_0)}{z - z_0}$$

exists. The limit is called the derivative of f at  $z_0$  and is denoted by  $f'(z_0)$  or  $\frac{df}{dz}(z_0)$ .

**Example 3.6**  $f(z) = z^2$ . Show that f'(z) = 2z.

**Example 3.7**  $f(z) = |z|^2$ . Show that this function is differentiable only at z = 0. In real analysis |x| is not differentiable but  $|x|^2$  is.

If a function is differentiable at z, then it is continuous at z.



### **Analytic Functions**

De• nition 3.4 A function is analytic in an open set if it has a derivative at each point in that set.

**De• nition 3.5** A function is analytic at a point  $z_0$  if it is analytic in some nbd of  $z_0$ .

**De• nition 3.6** A function is an entire function if it is analytic at all points of C.

**Example 3.13** f(z) = 1/z is analytic at all nonzero points.

**Example 3.14**  $f(z) = |z|^2$  is not analytic anywhere.

A function is not analytic at a point  $z_0$ , but is analytic at some point in each nbd of  $z_0$  then  $z_0$  is called the singular point of the function f.

#### **Harmonic Functions**

**De• nition 3.7** A real valued function H(x, y) is said to be harmonic in a domain of xy plane if it has continuous partial derivatives of the • rst and second order and satis• es Laplace equation:

$$H_{xx}(x, y) + H_y(x, y) = 0.$$



#### **Cauchy-Riemann Equations**

**Theorem 3.3** If  $f'(z_0)$  exists, then all the •rst order partial derivatives of component function u(x, y) and v(x, y) exist and satisfy Cauchy-Riemann Conditions:

$$u_x = v_y$$
  
 $u_y = -v_x$ .

**Example 3.8**  $f(z) = z^2 = x^2 - y^2 + i2xy$ . Show that Cauchy-Riemann Conditions are satisfied.

**Example 3.9**  $f(z) = |z|^2 = x^2 + y^2$ . Show that the Cauchy-Riemann Conditions are satis• ed only at z = 0.

**Theorem 3.4** Let f(z) = u(x, y) + iv(x, y) be de• ned in some nbd of the point  $z_0$ . If the • rst partial derivatives of u and v exist and are continuous at  $z_0$  and satisfy Cauchy-Riemann equations at  $z_0$ , then f is differentiable at  $z_0$  and

$$f'(z) = u_x + iv_x = v_y - iu_y.$$

**Example 3.10**  $f(z) = \exp(z)$ . Show that  $f'(z) = \exp(z)$ .

**Example 3.11**  $f(z) = \sin(z)$ . Show that  $f'(z) = \cos(z)$ .

**Example 3.12**  $f(z) = \frac{z^2}{z}$ . Show that the CR conditions are satis• ed at z = 0 but the function f is not differentiable at 0.



1. The Cauchy-Riemann equations for two functions u(x,y) and v(x,y) are

$$\frac{\partial u}{\partial x} = \frac{\partial v}{\partial y}$$
 and  $\frac{\partial u}{\partial y} = -\frac{\partial v}{\partial x}$ 

- (a) Show that  $u(x,y) = x^2 y^2$  and v(x,y) = 2xy satisfy the Cauchy–Riemann equations.


$$f_{xx} + f_{yy} = 0.$$

## Cauchy Integral Formula

R- a simply connected region



#. f(z) is assumed analytic in R but we multiply by a factor  $\frac{1}{(z-z_0)}$  that is analytic except at  $z_0$  and consider the integral around C

$$\int_{C} \frac{f(z)}{(z-z_0)} dz$$


#. To evaluate, consider the path  $C + c_1 + c_2 + C_0$  shown that encloses a simply – connected region for which the integrand is analytic on and inside the path:

$$\int_{C+\mathbb{N}_{\mathbf{x}}+\zeta_{\mathbf{x}}+C_{0}} \frac{f(z)}{(z-z_{0})} dz = 0 \implies \int_{C} \frac{f(z)}{(z-z_{0})} dz = -\int_{C_{0}} \frac{f(z)}{(z-z_{0})} dz$$



## Cauchy Integral Formula, cont'd

$$\int_{C} \frac{f(z)}{z - z_0} dz = -\int_{C_0} \frac{f(z)}{z - z_0} dz$$



Evaluate the  $C_0$  integral on a circular path,  $z-z_0=re^{i\theta}$ ,  $dz=rie^{i\theta}d\theta$ 

$$\int_{C_0} \frac{f(z)}{(z-z_0)} dz \stackrel{r\to 0}{=} f(z_0) \int_{2\pi}^0 \frac{f(z)^0}{\int_{e^{-\theta}}^{\theta} d\theta} = -2\pi i f(z_0) \qquad \text{for } r \to 0$$


$$\Rightarrow \int_{C} \frac{f(z)}{z - z_0} dz = 2\pi i f(z_0) \Rightarrow \int_{C} f(z_0) = \frac{1}{2\pi i} \oint_{C} \frac{f(z)}{z - z_0} dz$$



The value of f(z) at  $z_0$  is completely determined by its values on C!



## Cauchy Integral Formula, cont'd





Note that if  $z_0$  is outside C, the integrand is analytic inside C, hence by the Cauchy Integral Theorem,

$$\frac{1}{2\pi i} \oint_C \frac{f(z)}{z - z_0} dz = 0$$

In summary,

$$\oint \frac{f(z)}{z - z_0} dz = \begin{cases} 2\pi i \ f(z_0), & z_0 \text{ inside } C \\ 0, & z_0 \text{ outside } C \end{cases}$$



#### Contour Integral

If C is a contour in complex plane de• ned by z(t) = x(t) + iy(t) and a function f(z) = u(x, y) + iv(x, y) is de• ned on it. The integral of f(z) along the contour C is denoted and de• ned as follows:

$$\begin{split} \int_C f\left(z\right) dz &= \int_a^b f\left(z\right) z'\left(t\right) dt \\ &= \int_a^b (ux' - vy') dt + i \int_a^b (uy' + vx') dt \\ &= \int (udx - vdy) + i \int (udy + vdx) \end{split}$$

The component integrals are usual real integrals and are well de• ned. In the last form appropriate limits must placed in the integrals.


Some very straightforward rules of integration are given below:

- 1.  $\int_{C} w f(z) dz = w \int_{C} f(z) dz$  where w is a complex constant.
- 2.  $\int_{C} (f(z) + g(z)) dz = \int_{C} f(z) dz + \int_{C} g(z) dz$ .
- 3.  $\int_{C_1+C_2} f(z) dz = \int_{C_1} f(z) dz + \int_{C_2} f(z) dz$ .
- 4.  $\left| \int_{C} f(z) dz \right| \leq \int_{C} \left| f(z(t)) z'(t) \right| dt$ .
- 5. If  $|f(z)| \leq M$  for all  $z \in C$  then  $\left| \int_C f(z) dz \right| \leq ML$ , where L is length of the countour C.

**Example 4.4**  $f(z) = z^2$ . Find integral of f from (0,0) to (2,1) along a straight line and also along st line path from (0,0) to (2,0) and from (2,0) to (2,1).

**Example 4.5** f(z) = 1/z. Find the integral from (2,0) to (-2,0) along a semicircular path in upper plane given by |z| = 2.

**Example 4.6** Show that  $\left|\int_C f(z) dz\right| \leq \frac{\pi}{3}$  for  $f(z) = 1/(z^2 - 1)$  and C: |z| = 2 from 2 to 2i.



#### **Cauchy-Goursat Theorem**

**Theorem 4.1 (Jordan Curve Theorem)** Every simple and closed contour in complex plane splits the entire plane into two domains one of which is bounded. The bounded domain is called the interior of the countour and the other one is called the exterior of the contour.

De• ne a sense direction for a contour.

**Theorem 4.2** Let C be a simple closed contour with positive orientation and let D be the interior of C. If P and Q are continuous and have continuous partial derivatives  $P_x$ ,  $P_y$ ,  $Q_x$  and  $Q_y$  at all points on C and D, then

$$\int_{C} (P(x, y)dx + Q(x, y) dy) = \iint [Q_{x}(x, y) - P_{y}(x, y)] dxdy$$

**Theorem 4.3 (Cauchy-Goursat Theorem)** Let f be analytic in a simply connected domain D. If C is any simple closed contour in D, then

$$\int_{C} f(z) dz = 0.$$

**Example 4.7**  $f(z) = z^2, \exp(z), \cos(z)$  etc are entire functions so integral about any loop is zero.

**Theorem 4.4** Let  $C_1$  and  $C_2$  be two simple closed positively oriented contours such that  $C_2$  lies entirely in the interior of  $C_1$ . If f is an analytic function in a domain D that contains  $C_1$  and  $C_2$  both and the region between them, then

$$\int_{C_1} f(z) dz = \int_{C_2} f(z) dz.$$

**Example 4.8** f(z) = 1/z. Find  $\int_C f(z) dz$  if C is any contour containing origin. Choose a circular contour inside C.

**Example 4.9**  $\int_C \frac{1}{z-z_0} dz = 2\pi i$  if C contains  $z_0$ .

**Example 4.10** Find  $\int_C \frac{2zdz}{z^2+2}$  where C:|z|=2. Extend the Cauchy Goursat theorem to multiply connected domains.



#### **Singularities**

**De• nition 6.1** If a function f fails to be analytic at  $z_0$  but is analytic at some point in each neighbourhood of  $z_0$ , then  $z_0$  is a singular point of f.

**De• nition 6.2** If a function f fails to be analytic at  $z_0$  but is analytic at each z in  $0 < |z - z_0| < \delta$  for some  $\delta$ , then f is said to be an isolated singular point of f.

**Example 6.1** f(z) = 1/z has an isolated singularity at 0.

**Example 6.2**  $f(z) = 1/\sin(\pi z)$  has isolated singularities at  $z = 0, \pm 1, \ldots$ 


**Example 6.3**  $f(z) = 1/\sin(\pi/z)$  has isolated singularities at z = 1/n for integral n, also has a singularity at z = 0.

**Example 6.4**  $f(z) = \log z$  all points of negative x-axis are singular.

#### Types of singularities

If a function f has an isolated singularity at  $z_0$  then  $\exists$  a  $\delta$  such that f is analytic at all points in  $0 < |z - z_0| < \delta$ . Then f must have a Laurent series expansion about  $z_0$ . The part  $\sum_{n=1}^{\infty} b_1 (z - z_0)^{-n}$  is called the principal part of f.

- If there are in• nite nonzero b<sub>i</sub> in the prinipal part then z<sub>0</sub> is called an essential singularity of f.
- 2. If for some integer m,  $b_m \neq 0$  but  $b_i = 0$  for all i > m then  $z_0$  is called a pole of order m of f. If m = 1 then it is called a simple pole.
- If all bs are zero then z<sub>0</sub> is called a removable singularity.



#### Residues

Suppose a function f has an isolated singularity at  $z_0$ , then there exists a  $\delta>0$  such that f is analytic for all z in deleted nbd  $0<|z-z_0|<\delta$ . Then f has a Laurent series representation

$$f(z) = \sum_{n=0}^{\infty} a_n (z - z_0)^n + \sum_{n=1}^{\infty} \frac{b_n}{(z - z_0)^n}.$$

The coefe cient

$$b_{1}=\frac{1}{2\pi i}\int_{C}f\left( z\right) dz$$

where C is any contour in the deleted nbd, is called the residue of f at  $z_0$ .

**Example 6.6**  $f(z) = \frac{1}{z-z_0}$ . Then  $\int_C f(z) dz = 2\pi i b_1 = 2\pi i$  if C contains  $z_0$ , otherwise 0.

**Example 6.7**  $f(z) = \frac{1}{z(z-z_0)^4}$ . Show  $\int_C f(z) dz = -\frac{\pi i}{8} if C : |z-2| = 1$ .

**Example 6.8**  $f(z) = z \exp\left(\frac{1}{z}\right)$ . Show  $\int_C f(z) dz = \pi i \text{ if } C : |z| = 1$ .

**Example 6.9**  $f(z) = \exp\left(\frac{1}{z^2}\right)$ . Show  $\int_C f(z) dz = 0$  if C: |z| = 1 even though it has a singularity at z = 0.

**Theorem 6.1** If a function f is analytic on and inside a positively oriented countour C, except for a • nite number of points  $z_1, z_2, \ldots, z_k$  inside C, then

$$\int_{C} f(z) dz = 2\pi i \sum_{i=1}^{k} Resf(z_{i}).$$

Example 6.10 Show that  $\int \frac{5z-2}{z(z-1)} dz = 10\pi i$ 

#### **Residues of Poles**

**Theorem 6.2** If a function f has a pole of order m at  $z_0$  then

$$\operatorname{Resf}\left(z_{0}\right)=\lim_{z\to z_{0}}\left[\frac{1}{\left(m-1\right)!}\frac{d^{m-1}}{dz^{m-1}}\left(\left(z-z_{0}\right)^{m}f\left(z\right)\right)\right].$$

**Example 6.11**  $f(z) = \frac{1}{z-z_0}$ . Simple pole Res  $f(z_0) = 1$ .



**Example 6.12**  $f(z) = \frac{1}{z(z-z_0)^4}$ . Simple pole at z = 0. Res f(0) = 1/16. Pole of order 4 at z = 2. Res f(2) = -1/16.

$$\textbf{Example 6.13} \quad f\left(z\right) = \tfrac{\cos z}{z^2(z-\pi)^3}. \ \textit{Res } f\left(0\right) = -3/\pi^4. \ \textit{Res } f\left(\pi\right) = -\left(6-\pi^2\right)/2\pi^4.$$

#### **Quotients of Analytic Functions**

**Theorem 6.3** If a function  $f(z) = \frac{P(z)}{Q(z)}$ , where P and Q are analytic at  $z_0$ , then

- 1. f is singular at  $z_0$  iff  $Q(z_0) = 0$ .
- 2. f has a simple pole at  $z_0$  if  $Q'(z_0) \neq 0$ . Then residue of f at  $z_0$  is  $P(z_0)/Q'(z_0)$ .

### Isolated singularities



Removable singularities

Poles of finite order

Isolated essential singularities (pole of infinite order)

$$\frac{\sin(z)}{z}$$
,  $\frac{1-\cos(z)}{z^2}$ 

$$\frac{1}{z}$$
,  $\frac{1}{z^2}$ ,  $\frac{1}{(z-1)^m}$ 

$$\frac{2z+3}{\left(z-1\right)^2(z+2)}$$

$$\sin\left(\frac{1}{z}\right), e^{1/z}$$

These are each discussed in more detail next.



Essential singularities can be distinguished from poles by the fact that they cannot be removed by multiplying by a factor of finite value.

Example:

$$w = e^{1/2} = 1 + \frac{1}{z} + \frac{1}{2! z^2} + ... + \frac{1}{n! z^n} + ...$$
 infinite at the origin

We try to remove the singularity of the function at the origin by multiplying  $z^p$ 

$$z^{p}w = z^{p} + z^{p-1} + \frac{z^{p-2}}{2!} + \dots + \frac{z^{p-n}}{n!} + \dots$$

It consists of a finite number of positive powers of z, followed by an infinite number of negative powers of z.

All terms are positive

As 
$$z \to 0$$
,  $z^p w \to \infty$ 

It is impossible to find a finite value of p which will remove the singularity in  $e^{1/z}$  at the origin. The singularity is "essential".



## Singularities

### Examples of singularities:

(These will be discussed in more detail later.)

$$\frac{\sin(z)}{z}$$
 removable singularity at  $z = 0$ 

If expanded about the singularity, we can have:

T = Taylor

L = Laurent

N = Neither

$$\frac{1}{(z-z_s)^p}$$
 pole of order  $p$  at  $z=z_s$  ( if  $p=1$ , pole is a simple pole)

L 
$$e^{1/z}$$
 isolated essential singularity at  $z = z_0$  (pole of infinite order)

N 
$$\frac{1}{\sin\left(\frac{1}{z}\right)}$$
 non-isolated essential singularity  $z = 0$ 

N 
$$z^{1/2}$$
 branch point (*not* an isolated singularity)



### Barrier - Branch Cut

Barrier

The barrier must start from the branch point but it can go to infinity in any direction in the z plane, and may be either curved or straight.

In most normal applications, the barrier is drawn along the negative real axis.




-The barrier is termed the "branch cut".


-For the example given in the previous slide, the region, the barrier confines the function to the region in which the argument of z is within the range  $-\pi < \theta < \pi$ .



## Branch points

- The singularities described above arise from the non-analytic behaviour of single-valued functions.
- However, multi-valued functions frequently arise in the solution of engineering problems.
- For example:





For any value of z represented by a point on the circumference of the circle in the z plane, there will be two corresponding values of w represented by points in the w plane.



### Laurent's Theorem

Laurent series of a complex function f(z) is a representation of that function as a <u>power series</u> which includes terms of negative degree. It may be used to express complex functions in cases where a <u>Taylor series</u> expansion cannot be applied.



## Taylor's series

Taylor series is a representation of a <u>function</u>
 as an <u>infinite sum</u> of terms that are calculated




### The Residue Theorem

We saw that the integral of an analytic function f(z) over a closed curve C when f(z) has one singular point inside C is

$$\oint_C f(z)dz = 2\pi j b_1$$


 $b_1$  is the residue of f(z) at  $z_0$ 



Residue Theorem: Let f(z) be an analytic function inside and on a closed path C except for at k singular points inside C.

Then

$$\oint_C f(z)dz = 2\pi j \sum_{i=1}^k \operatorname{Res}_{z=z_i} f(z)$$

## Fourier Integral


If f(x) and f'(x) are piecewise continuous in every finite interval, and f(x) is absolutely integrable on R, i.e.

converges, then

$$\frac{1}{2}[f(x-)+f(x+)] = \frac{1}{2\pi} \int_{-\infty}^{\infty} e^{iwx} \left( \int_{-\infty}^{\infty} e^{-iwt} f(t) dt \right) dw$$

Remark: the above conditions are sufficient, but not necessary.







### 13.1.3 The Dirac δ-function

Before going on to consider further properties of Fourier transforms we make a digression to discuss the Dirac  $\delta$ -function and its relation to Fourier transforms. The  $\delta$ -function is different from most functions encountered in the physical sciences but we will see that a rigorous mathematical definition exists; the utility of the  $\delta$ -function will be demonstrated throughout the remainder of this chapter. It can be visualised as a very sharp narrow pulse (in space, time, density, etc.) which produces an integrated effect having a definite magnitude. The formal properties of the  $\delta$ -function may be summarised as follows.

The Dirac  $\delta$ -function has the property that

$$\delta(t) = 0 \quad \text{for } t \neq 0, \tag{13.11}$$

but its fundamental defining property is

$$\int f(t)\delta(t-a) dt = f(a), \qquad (13.12)$$

provided the range of integration includes the point t = a; otherwise the integral



▶ Find the Fourier transform of the normalised Gaussian distribution

$$f(t) = \frac{1}{\tau \sqrt{2\pi}} \exp\left(-\frac{t^2}{2\tau^2}\right), \quad -\infty < t < \infty.$$

This Gaussian distribution is centred on t = 0 and has a root mean square deviation  $\Delta t = \tau$ . (Any reader who is unfamiliar with this interpretation of the distribution should refer to chapter 30.)

Using the definition (13.5), the Fourier transform of f(t) is given by

$$\begin{split} \widetilde{f}(\omega) &= \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} \frac{1}{\tau \sqrt{2\pi}} \exp\left(-\frac{t^2}{2\tau^2}\right) \exp(-i\omega t) dt \\ &= \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} \frac{1}{\tau \sqrt{2\pi}} \exp\left\{-\frac{1}{2\tau^2} \left[t^2 + 2\tau^2 i\omega t + (\tau^2 i\omega)^2 - (\tau^2 i\omega)^2\right]\right\} dt, \end{split}$$

where the quantity  $-(\tau^2 i\omega)^2/(2\tau^2)$  has been both added and subtracted in the exponent in order to allow the factors involving the variable of integration t to be expressed as a complete square. Hence the expression can be written

$$\widetilde{f}(\omega) = \frac{\exp(-\frac{1}{2}\tau^2\omega^2)}{\sqrt{2\pi}} \left\{ \frac{1}{\tau\sqrt{2\pi}} \int_{-\infty}^{\infty} \exp\left[-\frac{(t+i\tau^2\omega)^2}{2\tau^2}\right] dt \right\}.$$

The quantity inside the braces is the normalisation integral for the Gaussian and equals unity, although to show this strictly needs results from complex variable theory (chapter 24). That it is equal to unity can be made plausible by changing the variable to  $s = t + i\tau^2 \omega$  and assuming that the imaginary parts introduced into the integration path and limits (where the integrand goes rapidly to zero anyway) make no difference.

We are left with the result that

$$\widetilde{f}(\omega) = \frac{1}{\sqrt{2\pi}} \exp\left(\frac{-\tau^2 \omega^2}{2}\right),$$
(13.7)

which is another Gaussian distribution, centred on zero and with a root mean square deviation  $\Delta \omega = 1/\tau$ . It is interesting to note, and an important property, that the Fourier transform of a Gaussian is another Gaussian.

In the above example the root mean square deviation in t was  $\tau$ , and so it is seen that the deviations or 'spreads' in t and in  $\omega$  are inversely related:

$$\Delta \omega \Delta t = 1$$
,

independently of the value of  $\tau$ . In physical terms, the narrower in time is, say, an electrical impulse the greater the spread of frequency components it must contain. Similar physical statements are valid for other pairs of Fourier-related variables, such as spatial position and wave number. In an obvious notation,  $\Delta k \Delta x = 1$  for a Gaussian wave packet.

The uncertainty relations as usually expressed in quantum mechanics can be related to this if the de Broglie and Einstein relationships for momentum and energy are introduced; they are

$$p = \hbar k$$
 and  $E = \hbar \omega$ .



equals zero. This leads immediately to two further useful results:

$$\int_{-a}^{b} \delta(t) dt = 1 \quad \text{for all } a, b > 0$$
 (13.13)

and

$$\int \delta(t-a) dt = 1, \tag{13.14}$$

provided the range of integration includes t = a.

Equation (13.12) can be used to derive further useful properties of the Dirac  $\delta$ -function:

$$\delta(t) = \delta(-t),\tag{13.15}$$

$$\delta(at) = \frac{1}{|a|}\delta(t),\tag{13.16}$$

$$t\delta(t) = 0. ag{13.17}$$



### ► Prove that $\delta(bt) = \delta(t)/|b|$ .

Let us first consider the case where b > 0. It follows that

$$\int_{-\infty}^{\infty} f(t)\delta(bt) dt = \int_{-\infty}^{\infty} f\left(\frac{t'}{b}\right) \delta(t') \frac{dt'}{b} = \frac{1}{b} f(0) = \frac{1}{b} \int_{-\infty}^{\infty} f(t)\delta(t) dt,$$

where we have made the substitution t' = bt. But f(t) is arbitrary and so we immediately see that  $\delta(bt) = \delta(t)/b = \delta(t)/|b|$  for b > 0.


Now consider the case where b = -c < 0. It follows that

$$\int_{-\infty}^{\infty} f(t)\delta(bt) dt = \int_{\infty}^{-\infty} f\left(\frac{t'}{-c}\right) \delta(t') \left(\frac{dt'}{-c}\right) = \int_{-\infty}^{\infty} \frac{1}{c} f\left(\frac{t'}{-c}\right) \delta(t') dt'$$
$$= \frac{1}{c} f(0) = \frac{1}{|b|} f(0) = \frac{1}{|b|} \int_{-\infty}^{\infty} f(t)\delta(t) dt,$$

where we have made the substitution t' = bt = -ct. But f(t) is arbitrary and so

$$\delta(bt) = \frac{1}{|b|}\delta(t),$$

for all b, which establishes the result.  $\triangleleft$ 



#### (i) Differentiation:

$$\mathscr{F}[f'(t)] = i\omega \widetilde{f}(\omega). \tag{13.28}$$

This may be extended to higher derivatives, so that

$$\mathscr{F}[f''(t)] = i\omega \mathscr{F}[f'(t)] = -\omega^2 \widetilde{f}(\omega),$$

and so on.

(ii) Integration:

$$\mathscr{F}\left[\int^{t} f(s) \, ds\right] = \frac{1}{i\omega} \widetilde{f}(\omega) + 2\pi c \delta(\omega), \tag{13.29}$$

where the term  $2\pi c\delta(\omega)$  represents the Fourier transform of the constant of integration associated with the indefinite integral.

(iii) Scaling:

$$\mathscr{F}[f(at)] = \frac{1}{a}\widetilde{f}\left(\frac{\omega}{a}\right).$$
 (13.30)


(iv) Translation:

$$\mathscr{F}[f(t+a)] = e^{ia\omega}\widetilde{f}(\omega). \tag{13.31}$$

(v) Exponential multiplication:

$$\mathscr{F}[e^{\alpha t}f(t)] = \widetilde{f}(\omega + i\alpha), \tag{13.32}$$

where a may be real, imaginary or complex.



#### ▶ Prove relation (13.28).

Calculating the Fourier transform of f'(t) directly, we obtain

$$\mathscr{F}[f'(t)] = \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} f'(t) e^{-i\omega t} dt$$

$$= \frac{1}{\sqrt{2\pi}} \left[ e^{-i\omega t} f(t) \right]_{-\infty}^{\infty} + \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} i\omega e^{-i\omega t} f(t) dt$$

$$= i\omega \tilde{f}(\omega),$$

if  $f(t) \to 0$  at  $t = \pm \infty$ , as it must since  $\int_{-\infty}^{\infty} |f(t)| dt$  is finite.



### Example 15.4.2 HEAT FLOW PDE

To illustrate another transformation of a PDE into an ODE, let us Fourier transform the heat flow partial differential equation

$$\frac{\partial \psi}{\partial t} = a^2 \frac{\partial^2 \psi}{\partial x^2},$$

where the solution  $\psi(x,t)$  is the temperature in space as a function of time. By taking the Fourier transform of both sides of this equation (note that here only  $\omega$  is the transform variable conjugate to x because t is the time in the heat flow PDE), where

$$\Psi(\omega, t) = \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} \psi(x, t) e^{i\omega x} dx,$$

this yields an ODE for the Fourier transform  $\Psi$  of  $\psi$  in the time variable t,

$$\frac{\partial \Psi(\omega, t)}{\partial t} = -a^2 \omega^2 \Psi(\omega, t).$$

Integrating we obtain

$$\ln \Psi = -a^2 \omega^2 t + \ln C$$
, or  $\Psi = C e^{-a^2 \omega^2 t}$ ,

where the integration constant C may still depend on  $\omega$  and, in general, is determined by initial conditions. In fact,  $C = \Psi(\omega, 0)$  is the initial spatial distribution of  $\Psi$ , so it is given by the transform (in x) of the initial distribution of  $\psi$ , namely,  $\psi(x, 0)$ . Putting this solution back into our inverse Fourier transform, this yields

$$\psi(x,t) = \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} C(\omega) e^{-i\omega x} e^{-a^2 \omega^2 t} d\omega.$$

For simplicity, we here take  $C \omega$ -independent (assuming a delta-function initial temperature distribution) and integrate by completing the square in  $\omega$ , as in Example 15.1.1,

making appropriate changes of variables and parameters  $(a^2 \to a^2 t, \ \omega \to x, t \to -\omega)$ . This yields the particular solution of the heat flow PDE,

$$\psi(x,t) = \frac{C}{a\sqrt{2t}} \exp\left(-\frac{x^2}{4a^2t}\right),$$

which appears as a clever guess in Chapter 8. In effect, we have shown that  $\psi$  is the inverse Fourier transform of  $C \exp(-a^2 \omega^2 t)$ .

#### 15.5 CONVOLUTION THEOREM


We shall employ convolutions to solve differential equations, to normalize momentum wave functions (Section 15.6), and to investigate transfer functions (Section 15.7).

Let us consider two functions f(x) and g(x) with Fourier transforms F(t) and G(t), respectively. We define the operation

$$f * g \equiv \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} g(y) f(x - y) dy$$
 (15.52)

as the **convolution** of the two functions f and g over the interval  $(-\infty, \infty)$ . This form of an integral appears in probability theory in the determination of the probability density of two random, independent variables. Our solution of Poisson's equation, Eq. (9.148), may be interpreted as a convolution of a charge distribution,  $\rho(\mathbf{r}_2)$ , and a weighting function,  $(4\pi \varepsilon_0 |\mathbf{r}_1 - \mathbf{r}_2|)^{-1}$ . In other works this is sometimes referred to as the **Faltung**, to use the

German term for "folding." We now transform the integral in Eq. (15.52) by introducing the Fourier transforms:

$$\int_{-\infty}^{\infty} g(y)f(x-y)dy = \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} g(y) \int_{-\infty}^{\infty} F(t)e^{-it(x-y)} dt dy$$

$$= \frac{1}{\sqrt{2\pi}} \int_{-\infty}^{\infty} F(t) \left[ \int_{-\infty}^{\infty} g(y)e^{ity} dy \right] e^{-itx} dt$$

$$= \int_{-\infty}^{\infty} F(t)G(t)e^{-itx} dt, \qquad (15.53)$$

interchanging the order of integration and transforming g(y). This result may be interpreted as follows: The Fourier inverse transform of a **product** of Fourier transforms is the convolution of the original functions, f \* g.

For the special case x = 0 we have

$$\int_{-\infty}^{\infty} F(t)G(t) dt = \int_{-\infty}^{\infty} f(-y)g(y) dy.$$
 (15.54)

The minus sign in -y suggests that modifications be tried. We now do this with  $g^*$  instead of g using a different technique.

## Real Integration Theorem

This theorem establishes the relationship between the Laplace transform of a function and that of its integral. It states that

$$\mathcal{L}\left[\int_0^t f(t) dt\right] = \frac{1}{s}F(s)$$
 (2-1.7)

The proof of this theorem is carried out by integrating the definition of the Laplace transform by parts. This proof is similar to that of the real differentiation theorem and is left as an exercise. The Laplace transform of the nth integral of a function is the transform of the function divided by  $s^n$ .

$$L(f^{n}) = s^{n}L(f) - s^{n-1}f(0) - s^{n-2}f'(0) - \dots - f^{n-1}(0)$$



#### For first-order derivative:

$$\mathcal{L}\left\{f'(t)\right\} = s\,\mathcal{L}\left\{f(t)\right\} - f(0)$$

For second-order derivative:

$$\mathcal{L}\left\{f''(t)\right\} = s^2 \mathcal{L}\left\{f(t)\right\} - s f(0) - f'(0)$$

For third-order derivative:

$$\mathcal{L}\left\{f'''(t)\right\} = s^3 \mathcal{L}\left\{f(t)\right\} - s^2 f(0) - s f'(0) - f''(0)$$

For n<sup>th</sup> order derivative:

$$\mathcal{L}\left\{f^{n}(t)\right\} = s^{n}\mathcal{L}\left\{f(t)\right\} - s^{n-1}f(0) - s^{n-2}f'(0) - \dots - f^{n-1}(0)$$



# The Laplace Transform of the First Derivative

$$L\left|\frac{f'(t)}{f(t)}\right| = s L\left|\frac{f(t)}{f(t)}\right| - f(0)$$

$$L \left[ \frac{f'(t)}{f'(t)} \right] = \int_0^\infty e^{-st} \frac{f(t)dt}{dv}$$

$$\int u dv = uv - \int v du$$

$$L\left[f'(t)\right] = \int u dv = e^{-st} f(t) \int_0^\infty -\int_0^\infty f(t)(-s) e^{-st} dt$$



## The Laplace Transform of the Third Derivative

$$L \begin{bmatrix} f'(t) \end{bmatrix} = sL \begin{bmatrix} f(t) \end{bmatrix} - f(0)$$

$$L \begin{bmatrix} f''(t) \end{bmatrix} = s^2 L \begin{bmatrix} f(t) \end{bmatrix} - sf(0) - f'(0)$$

$$L[f'''(t)] = sL[f''(t)] - f''(0)$$

$$= s[s^2 L[f(t)] - f(0) - f'(0)] - f''(0)$$

#### Application to linear differential equations

We illustrate the Laplace transform technique by a simple example of harmonic oscillator with a time-dependent external force f(t) = t.

$$\ddot{x} + \omega^2 x = t \,, \tag{15}$$

$$x(0) = a$$
,  $\dot{x}(0) = b$ . (16)

The starting point is to Laplace-transform the equation:

$$\int_{0}^{\infty} dt \, e^{-pt} \left[ \ddot{x} + \omega^{2} x \right] = \int_{0}^{\infty} dt \, e^{-pt} t \,. \tag{17}$$

For the derivatives in the l.h.s. of (17) we use (4), with (16) taken into account. This yields

$$\int_{0}^{\infty} dt \, e^{-pt} \left[ \ddot{x} + \omega^{2} x \right] = (p^{2} + \omega^{2}) X(p) - pa - b , \qquad (18)$$

where

$$X(p) = \int_0^\infty dt \, e^{-pt} x(t)$$
. (19)

The integral in the r.h.s. of (17) needs to be done explicitly:

$$\int_0^\infty dt \, e^{-pt} t = -\frac{\partial}{\partial p} \int_0^\infty dt \, e^{-pt} = -\frac{\partial}{\partial p} \frac{1}{p} = \frac{1}{p^2}. \quad (20)$$

We thus have

$$(p^2 + \omega^2)X(p) - pa - b = \frac{1}{p^2},$$
 (21)

and find

$$X(p) = \frac{1 + p^2(pa + b)}{p^2(p^2 + \omega^2)} = \frac{1 + p^2(pa + b)}{p^2(p - i\omega)(p + i\omega)}$$
. (22)



Now we perform the inverse transform

$$x(t) = \frac{1}{2\pi i} \int_C \frac{[1+p^2(pa+b)]e^{pt}}{p^2(p-i\omega)(p+i\omega)} dp.$$
 (23)

That is we sum up all the residues of the function

$$\frac{\left[1+p^2(pa+b)\right]e^{pt}}{p^2(p-i\omega)(p+i\omega)}.$$
(24)

There are three poles. The two simple poles  $p = \pm i\omega$  come from the l.h.s. of the original differential equation, while the second-order pole at p = 0 is totally due to the particular form of the external force. The residue calculus routine leads to the final answer

$$x(t) = t/\omega^2 + a\cos\omega t + (b/\omega - 1/\omega^3)\sin\omega t. \tag{25}$$



**Problem 45.** Use the Laplace transform method to solve for the evolution of a damped harmonic oscillator with a time-independent external force:

$$\ddot{x} + \omega^2 x + \gamma \dot{x} = f_0 \,, \tag{26}$$

$$x(0) = 0$$
,  $\dot{x}(0) = 0$ , (27)

Find x(t); make sure it is real and does satisfy the equation and the initial conditions. Compare two cases:  $0 < \gamma < 2\omega$  and  $\gamma \ge 2\omega$ .

If we are dealing with a system of linear differential equations, the procedure is the same. We Laplace-transform each of the equations and arrive at a system of *algebraic* equations for the Laplace transforms of the unknown functions. From this system we find each of the Laplace transforms and then perform the inverse transforms.



**Problem 46.** Use the Laplace transform method to solve for the evolution of one of two coupled harmonic oscillators (the coupling force is proportional to the relative displacement of the oscillators, the proportionality coefficient  $\lambda > 0$ ):

$$\ddot{x}_1 + \omega_1^2 x_1 = \lambda (x_2 - x_1) , \qquad (28)$$

$$\ddot{x}_2 + \omega_2^2 x_2 = \lambda (x_1 - x_2) . (29)$$

Find  $x_1(t)$  for t > 0 under the following initial conditions:

$$x_1(0) = 0$$
,  $\dot{x}_1(0) = 0$ ,  $x_2(0) = 0$ ,  $\dot{x}_2(0) = 1$ . (30)

Make sure  $x_1(t)$  is real and does satisfy the initial conditions.




## Laplace Transform

- Applications of the Laplace transform
  - solve differential equations (both ordinary and partial)
  - application to RLC circuit analysis
- Laplace transform converts differential equations in the time domain to algebraic equations in the frequency domain, thus 3 important processes:
  - (1) transformation from the time to frequency domain
  - (2) manipulate the algebraic equations to form a solution
  - (3) inverse transformation from the frequency to time domain



# Laplace transform of an impulse 'function' (Dirac delta distribution)



$$L(\delta(t)) = \lim_{\varepsilon \to 0} \int_{0}^{\varepsilon} \frac{1}{\varepsilon} e^{-st} dt = \frac{-1}{s\varepsilon} e^{-st} \Big|_{0}^{\varepsilon} =$$

$$\lim_{\varepsilon \to 0} \left( \frac{\left[ e^{-s\varepsilon} - 1 \right]}{-s\varepsilon} \right)$$

Writing  $e^x$  as a McLaurin series

$$e^{x} = 1 + x + \frac{1}{2!}x^{2} + \frac{1}{3!}x^{3}h.o.t.$$

Writing  $e^{-s\varepsilon}$  as a McLaurin series

$$e^{-s\varepsilon} = 1 + (-s\varepsilon) + \frac{1}{2!}(-s\varepsilon)^2 + \frac{1}{3!}(-s\varepsilon)^3 h.o.t.$$



#### Laplace transform of impulse (Dirac delta distribution)

$$e^{-s\varepsilon} - 1 = (-s\varepsilon) + \frac{1}{2!}(-s\varepsilon)^2 + \frac{1}{3!}(-s\varepsilon)^3 + h.o.t.$$

$$\frac{e^{-s\varepsilon}-1}{-s\varepsilon}=1+\frac{1}{2!}(-s\varepsilon)+\frac{1}{3!}(-s\varepsilon)^2+h.o.t.$$

$$L(\delta(t)) = \lim_{\varepsilon \to 0} \left[ \frac{e^{-s\varepsilon} - 1}{-s\varepsilon} \right] = \lim_{\varepsilon \to 0} \left[ 1 + \frac{1}{2!} (-s\varepsilon) + \frac{1}{3!} (-s\varepsilon)^2 + h.o.t. \right] = 1$$

$$L(\delta(t))=1$$
