## **Poisson's and Laplace's Equations**

• These can be derived from Gauss's law:

$$\nabla \cdot \boldsymbol{\varepsilon} \mathbf{E} = \boldsymbol{\rho}_{v}$$
$$\nabla \cdot -\boldsymbol{\varepsilon} \nabla V = \boldsymbol{\rho}_{v}$$

• For a homogeneous medium:

$$\nabla^2 V = -\frac{\rho_v}{\varepsilon}$$
 Poisson's Equation

- Relates the potential at a point to the source at that point
- For a source free region



Laplace's Equation

• These two are the governing equations to solve electrostatic problems

- ∇<sup>2</sup> is a linear differential operator which can be derived using the expression of ∇
- In Cartesian coordinate system

$$\nabla^2 = \frac{\partial^2}{\partial x^2} + \frac{\partial^2}{\partial y^2} + \frac{\partial^2}{\partial z^2}$$

• In the cylindrical coordinate system

$$\nabla^{2} = \frac{1}{\rho} \frac{\partial}{\partial \rho} \left( \rho \frac{\partial}{\partial \rho} \right) + \frac{1}{\rho^{2}} \frac{\partial^{2}}{\partial \phi^{2}} + \frac{\partial^{2}}{\partial z^{2}}$$

• In the spherical coordinate system

$$\nabla^2 = \frac{1}{r^2} \frac{\partial}{\partial r} \left( r^2 \frac{\partial}{\partial r} \right) + \frac{1}{r^2 \sin \theta} \frac{\partial}{\partial \theta} \left( \sin \theta \frac{\partial}{\partial \theta} \right) + \frac{1}{r^2 \sin^2 \theta} \frac{\partial^2}{\partial \phi^2}$$

#### • <u>Uniqueness Theorem:</u>

- Exact solution of Poisson's equation and Laplace's equation for a given geometry can be determined by applying appropriate boundary conditions

- For a given geometry and boundary conditions, the solution of these equations is unique

#### **General Procedure for Solving Poisson's or Laplace's Equations**

- Direct integration: If the domain geometry is one dimensional and simple
- Separation of variables: For two- or three-dimensional problems
- Numerical techniques: Can handle complex two- or three-dimensional problems with anisotropy/inhomogeneity

#### **Resistance and Capacitance**

<u>Resistance:</u>

$$R = \frac{V}{I} = \frac{\int_{L} \mathbf{E} \cdot d\mathbf{l}}{\int_{S} \sigma \mathbf{E} \cdot d\mathbf{S}}$$

- Resistance for complicated structures can be determined using the following steps:
- 1. Choose a suitable coordinate system.
- 2. Assume  $V_0$  as the potential difference between conductor terminals.
- 3. Solve Laplace's equation  $\nabla^2 V = 0$  to obtain V. Then determine E from  $\mathbf{E} = -\nabla V$  and find I from  $I = \int_S \sigma \mathbf{E} \cdot d\mathbf{S}$ .
- 4. Finally, obtain R as  $V_o/I$ .

#### Capacitance:

$$C = \frac{Q}{V} = \frac{\varepsilon \int_{S} \mathbf{E} \cdot d\mathbf{S}}{\int_{L} \mathbf{E} \cdot d\mathbf{l}}$$

- Two approaches:
- 1. Assuming Q and determining V in terms of Q (involving Gauss's law)
- 2. Assuming V and determining Q in terms of V (involving solving Laplace's equation)
- The capacitance value depends on material properties and objects in vicinity

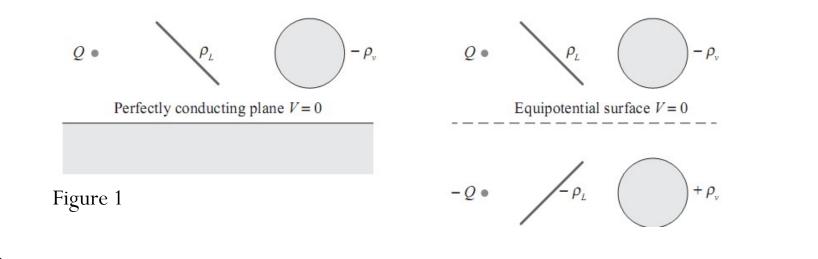
## Method of images and its applications

The **image theory** states that a given charge configuration above an infinite grounded perfect conducting plane may be replaced by the charge configuration itself, its image, and an equipotential surface in place of the conducting plane.

• Solving Laplace's and Poisson's equation is avoided.

The following conditions must be satisfied to apply the image method:

- The image charge(s) must be located in the conducting region
- The image charge(s) must be located such that on the conducting surface(s) the potential is zero or constant



#### **Application of Poisson's and Laplace's Equations**

•They are useful for finding out surface charge densities and electric field in the regions of interest.

•They can be used to find out the capacitance of different structures by the application of boundary conditions appropriately.
