Frequency Response Analysis:-

> Frequency response:-

It is defend as the steady state response of a system when the Enput to the system is a sinusodial signal.

The magnitude and phase relationship between the sinusodial input and the steady state output of a system is termed the prequency response. In linier time invariant systems the prequency response is independent of the

The frequency response is normally obtained by varying the frequency of the input signal by keeping the magnitude of the input signal at a constant value.

In the system transfer function T(s), if s is replaced by JW then the resulting transfer function T(JW) is called sinusodial transfer function. The The frequency response of the system can be directly obtained from the sinusodial transfer function T(JW) of the system. The transfer function T(JW) is a complex function of frequency. The magnitude and phase of T(JW) are function of frequency and can be evolved evolvated for various values of frequency.

where M te the rate of the amplitudes of the output and Enput sinusoid and te called as the 'magnitude rate 'or gate also.

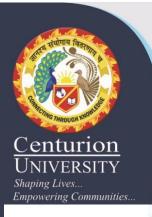
o Es the angle by whech the output leads the Enput. Both M and o are the functions of the angular frequency w.



Methods En Frequency response:-

The magnitude function and phase function are the two plots in the frequency response characteristics. The angular frequency (w) is the common variable for both these plots.

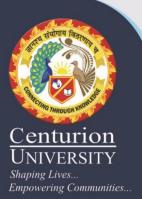
The following curves are mainly used in frequency response analysis. i, polar plot: The plot of the magnitude versus phase angle in polar coordinate where w is varied from a tass is called polar plot. i, Bode plot: The plots of both i magnitude and i, phase versus frequency with logarithmic values are called Bode plot.



* Advantages of frequency domain specifications:-

- i, without the knowledge of the transfer function the frequency response of stable open loop system can be obtained experimentally.
- ii, There methods are easy to use for design of control systems and for finding absolute as well as relative stability of the system. calculations are simple.
- in, The apparatus requêred for obtaining frequency response is simple and inexpensive and easy to use.
- iv, The transfer functions of complicated egeterne can be determined experimentally by frequency response texts.
- Y. When system is designed by the use of frequency response analysis, the effects of noise disturbance and parameter variations are relatively easy to visualize and incorporate corrective measures.

The max^m value of the magnitude of closed loop transfer function is called the secretainant peak Mr, A large retainant peak corresponde to a large overshoot in transfert response.

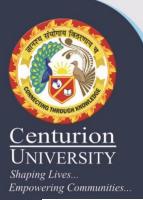
i, Resonant frequency:- (wr)

The frequency at which the resonant peak occurs is called resonant frequency wr. This is related to the frequency of oscillation in the step response and thus it is inclicative of the speed of the fransient response.

* cut-off rate:-

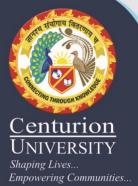
The slope of the log magnitude curve near the cut off frequency is called the cut off rate. The cut off rate & the ability of the system to distinguish the signal from noise.

* Gath Margin >

The gain Margin (Kg) is defined as the reciprocal of the magnitude of open loop transfer function at phase cross over frequency. The frequency at which the phase of open loop transfer function is 180° is called the phase cross over frequency, wpc.

The gain cross over frequency was is the frequency at which the magnitude of the open loop transfer function is unity (or it is the frequency at which the db magnitude is zero.

The phase margen (Y) is obtained by adding 180° to the phase angle Φ of the open loop transfer function at the gain cross over frequency.
