
Frequency compensation





Compensation of two-stage op amps




- We identify three poles at X(or Y), E(orF) and A(orB).
 - A pole at X(or Y) lies at relatively high frequencies. Since the resistance seen at E is quite high, even the capacitances of I can create a pole relatively close to the origin. At node I, the resistance is lower but the value of I may be quite high. Conscircuit exhibits I two dominant poles.
- One of the dominant noise must be moved toward the origin s



- In a two-stage amp as shown in Fig.(a), the first stage exhibits a impedance and the second stage provides a moderate gain, the providing a suitable environment for Miller multiplication of capac
- In Fig.(b), we create a large capacitance at E, the pole is \(\textit{\textit{g}} = \frac{1}{R} \)
 As a result, a low-frequency pole can be established with a mode capacitor value, saving considerable chip area.






For C_C = 0 and relatively large C_L, ω_{p,2} ≈ 1/(R_LC_L). For C_C ≠ 0 and C_C + C_{GD9} >> C_E, ω_{p,2} ≈ g_{m9}/(C_E + C_L).


Typically C_E << C_L, we conclude that Miller compensation increases the magnitude of the output




- Effect of right half plane zero
 - The circuit contains a right-half-plane zero at $\omega_z = g_{m9}/(C_C + C_{GD9})$ because $C_C + C_{GD9}$ forms a "parasitic" signal path from the input to the output.
 - A zero in the right hand plane contributes more phase shift, thus moving the phase crossover toward the origin. Furthermore, from Bode approximations, the zero slows down the drop of the magnitude, thereby pushing the gain crossover away from the origin. As a result, the stability degrades considerably.
 - □ For two-stage op amps, typically $|\omega_{p1}| < |\omega_z| < |\omega_{p2}|$, the zero introduces significant phase shift while









- ☐ The zero is given by . If $R \ge g^{-1}$, then $\omega \le 0$.
- We may move the zero well into the left plane so as to can nondominant pole. 

 \square If I_1 is chosen with respect to I_{D9} such that

we have
