## Session\_10

## Laurent's Series

If a single valued function f(z) is analytic inside and on the boundaries of a ring shaped region (annulus) S bounded by two concentric circles  $C_1$  and  $C_2$  of radii  $r_1$  and  $r_2$  ( $r_1 > r_2$ ) respectively having centre at a, then for all z is S,

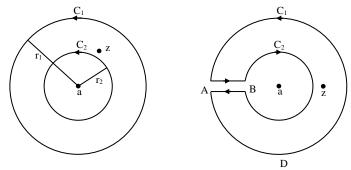
 $f(z) = A_0 + A_1(z-a) + A_2(z-a)^2 + \dots + B_1(z-a)^{-1} + B_2(z-a)^{-2} + \dots$ 

or, 
$$f(z) = \sum_{n=0}^{\infty} A_n (z-a)^n + \sum_{n=1}^{\infty} B_n (z-a)^{-n}$$

where,  $A_n = \frac{1}{2\pi i} \iint_{C_1} \frac{f(t)}{(t-a)^{n+1}} dt$ ;  $n = 0, 1, 2, \cdots$ 

and  $B_n = \frac{1}{2\pi i} \iint_{C_2} \frac{f(t)}{(t-a)^{-n+1}} dt$ ;  $n = 1, 2, 3 \cdots$ 

**Proof:** 



By introducing a cross AB the ring shaped region S, bounded by two circles  $C_1$  and  $C_2$  was converted into a simply connected region, bounded by a simple closed curve say D.

Let z be an interior point and t be a boundary point of the simple connected region.

: By Cauchy's integral formula, we have

$$f(z) = \frac{1}{2\pi i} \oint_{D} \frac{f(t)}{t-z} dt$$

$$= \frac{1}{2\pi i} \left[ \iint_{C_1} \frac{f(t)}{t-z} dt + \int_{AB} \frac{f(t)}{t-z} dt + \iint_{C_2} \frac{f(t)}{t-z} dt + \int_{BA} \frac{f(t)}{t-z} dt \right]$$

$$= \frac{1}{2\pi i} \left[ \iint_{C_1} \frac{f(t)}{t-z} dt + \iint_{C_2} \frac{f(t)}{t-z} dt \right] \left( \begin{array}{c} \because \text{ Integrals along} \\ AB \text{ and } BA \text{ are cancelled out} \end{array} \right)$$

$$\Rightarrow f(z) = \frac{1}{2\pi i} \iint_{C_1} \frac{f(t)}{t-z} dt - \frac{1}{2\pi i} \iint_{C_2} \frac{f(t)}{t-z} dt \qquad (5)$$

where  $C_1$  and  $C_2$  are traversed in anticlock-wise direction.

For the 1<sup>st</sup> integral in (5), *t* lies on 
$$C_1$$

$$\therefore |z-a| < |t-a| \text{ i.e., } \left| \frac{z-a}{t-a} \right| < 1$$

Now, 
$$\frac{1}{t-z} = \frac{1}{(t-a)-(z-a)} = \frac{1}{t-a} \left[ 1 - \frac{z-a}{t-a} \right]^{-1}$$
$$= \frac{1}{t-a} \left[ 1 + \left(\frac{z-a}{t-a}\right) + \left(\frac{z-a}{t-a}\right)^2 + \dots \right] \left( \begin{array}{c} \text{Expanding} \\ \text{Binomilly} \end{array} \right)$$

Multiplying both sides by  $\frac{f(t)}{2\pi i}$  and integrating term by term w.r.t. t along the circle  $C_1$ , we obtain

(9)

$$\frac{1}{2\pi i} \iint_{C_1} \frac{f(t)}{t-z} dt = \frac{1}{2\pi i} \iint_{C_1} \frac{f(t)}{t-a} dt + \frac{z-a}{2\pi i} \iint_{C_1} \frac{f(t)}{(z_x-a)^2} dt + \frac{(z-a)^2}{2\pi i} \iint_{C_1} \frac{f(t)}{(t-a)^3} dt + \cdots$$
$$= A_0 + A_1(z-a) + A_2(z-a)^2 + \cdots$$
$$= \sum_{n=0}^{\infty} A_n \left(z-a\right)^n \tag{6}$$

where  $A_n = \frac{1}{2\pi i} \prod_{l=0}^{\infty} \frac{f(t)}{(t-a)^{n+1}} dt$ ;  $n = 0, 1, 2, \cdots$ 

For the 2<sup>nd</sup> integral in (5); *t* lies on  $C_2$ 

$$\therefore |t-a| < |z-a| \quad \text{or} \quad \left|\frac{t-a}{z-a}\right| < 1$$
Now  $\frac{1}{t-z} = \frac{1}{(t-a)-(z-a)} = -\frac{1}{z-a} \left[1 - \frac{t-a}{z-a}\right]^{-1}$ 

$$\Rightarrow -\frac{1}{t-z} = \frac{1}{z-a} \left[1 + \left(\frac{t-a}{z-a}\right) + \left(\frac{t-a}{z-a}\right)^2 + \cdots\right] \begin{pmatrix}\text{Expanding}\\\text{Binomially}\end{pmatrix}$$

Multiplying both sides by  $\frac{f(t)}{2\pi i}$  and integrating term by term w.r.t. t along the circle  $C_2$ , we obtain

$$-\frac{1}{2\pi i} \oint_{C_2} \frac{f(t)}{t-z} dt = \frac{1}{2\pi i (z-a)} \oint_{C_2} f(t) dt + \frac{1}{(z-a)^2} \cdot \frac{1}{2\pi i} \oint_{C_2} (t-a) f(t) dt + \frac{1}{(z-a)^3} \cdot \frac{1}{2\pi i} \oint_{C_2} (t-a)^2 f(t) dt + \cdots = B_1 (z-a)^{-1} + B_2 (z-a)^{-2} + B_3 (z-a)^{-3} + \cdots = \sum_{n=1}^{\infty} B_n (z-a)^{-n}$$
(8)  
where,  $B_n = \frac{1}{2\pi i} \iint_{C_2} \frac{f(t)}{(t-a)^{-n+1}} dt$ ;  $n = 1, 2, 3, \cdots$ 

Substituting the values from (6) and (8) in (5), we obtain;

$$f(z) = \sum_{n=0}^{\infty} A_n (z-a)^n + \sum_{n=1}^{\infty} B_n (z-a)^{-n}$$
(10)  
where  $A_n$  and  $B_n$  are given in (7) and (9).

Note:

(1) In the Laurent expansion (10) of a complex valued function f(z), the first part  $\sum_{n=0}^{\infty} A_n (z-a)^n$  is called the **analytic-part** of Laurent's series which is similar to the Taylor's series of the function and the remainder  $\sum_{n=1}^{\infty} B_n (z-a)^{-n}$  is known as the **principal part** of the Laurent's series. The second summation is of chief interest, since it contains the singularity.

(2) In the statement of Laurent's series,

$$A_n = \frac{1}{2\pi i} \bigoplus_{c_1} \frac{f(t)}{(t-a)^{n+1}} dt \neq \frac{f^n(a)}{n!}, \text{ because } f(z) \text{ is not given to be analytic inside } C_1$$

(3) In case f(z) is analytic inside  $C_1$  (or inside  $C_2$ ), then  $B_n = 0$  and  $A_n = \frac{1}{2\pi i} \iint_{C_1} \frac{f(t)}{(t-a)^{n+1}} dt = \frac{f^n(a)}{n!}$  and Laurent's series reduces to Taylor's series.

(4) If C is any simple closed curve lying in the ring shaped region S and enclosing the circle  $C_2$ , then

$$\int_{C_1} \frac{f(t)}{(t-a)^{n+1}} dt = \iint_C \frac{f(t)}{(t-a)^{n+1}} dt$$

 $\iint_{C_2} \frac{f(t)}{(t-a)^{-n+1}} dt = \iint_{C} \frac{f(t)}{(t-a)^{-n+1}} dt$ 

and

: Laurent's series can be expressed as

$$f(t) = \sum_{n=-\infty}^{\infty} A_n (z-a)^n$$
, where  $A_n = \frac{1}{2\pi i} \prod_{C} \frac{f(t)}{(t-a)^{n+1}} dt$ 

(5) The process of finding the coefficient  $A_n$  by complex integration is complicated.

In practice, we expand the function f(z) by binomial theorem.
