## Laplace's Equation, Harmonic and conjugate harmonic Functions

Theorem 1:

If f(z) = u(x, y) + iv(x, y) is analytic in a domain D, then u & v satisfy Laplace's equation.

i.e. 
$$\nabla^2 u = u_{xx} + u_{yy} = 0$$
  
&  $\nabla^2 v = v_{xx} + v_{yy} = 0$ 

respectively in D and both have continuous 2nd order partial derivative in D.

### Proof:

Let given f(z) = u(x, y) + iv(x, y) be analytic

$$\Rightarrow u_x = v_y \quad \& \quad u_y = -v_x \quad (by C-R \text{ equations})$$

So  $u_{xx} = v_{yx}$  &  $u_{yy} = -v_{xy}$ 

#### Laplace's Equation:

Let u(x, y) be a real valued function of two variables possessing 2<sup>nd</sup> order partial derivatives in a domain *D*.

If  $\nabla^2 u = u_{xx} + u_{yy} = 0$ , then this equation is known as Laplace's equation and u(x, y) is said to satisfy the Laplace's equation.

so,  $\nabla^2 u = u_{xx} + u_{yy} = 0 \implies \nabla^2 u$  satisfies Laplace's equation

Similarly  $v_x = -u_y \Longrightarrow v_{xx} = -u_{yx}$ 

& 
$$v_y = u_x \Longrightarrow v_{yy} = u_{xy}$$

$$:: \nabla^2 v = v_{xx} + v_{yy} = -u_{yx} + u_{xy} = 0$$

or 
$$\nabla^2 v = v_{xx} + v_{yy} = 0$$

 $\Rightarrow$  v satisfies Laplace's equation.

# Harmonic function:

The function u(x, y) is said to be harmonic if it satisfies Laplace's equation i.e.  $\nabla^2 u = u_{xx} + u_{yy} = 0$ .

**Theorem 2:** If f(z) = u(x, y) + iv(x, y) is an analytic function then its real and imaginary parts i.e. u & v are harmonic.

## Proof:

Since f(z) = u + iv is analytic so it satisfies the C-R equations.

$$\Rightarrow \frac{\partial u}{\partial x} = \frac{\partial v}{\partial y} \tag{9}$$

$$\&\frac{\partial u}{\partial y} = -\frac{\partial v}{\partial x}$$
(10)

Differentiating (9) partially w.r.t. x & (10) partially w.r.t y; we obtain

$$\frac{\partial^2 u}{\partial x^2} = \frac{\partial^2 v}{\partial x \partial y} \tag{11}$$

And 
$$\frac{\partial^2 u}{\partial y^2} = -\frac{\partial^2 v}{\partial y \partial x}$$
 (12)

Assuming that partial derivatives of u & v of  $1^{st}$  and  $2^{nd}$  orders exist and are continuous functions of x & y; it follows that;

$$\frac{\partial^2 v}{\partial x \partial y} = \frac{\partial^2 v}{\partial y \partial x}$$

Adding (3) & (4) we obtain

$$\frac{\partial^2 u}{\partial x^2} + \frac{\partial^2 u}{\partial y^2} = 0$$
(13)

By differentiating (9) partially w.r.t. y and (10) partially w.r.t. x and subtracting, we obtain:

$$\frac{\partial^2 v}{\partial x^2} + \frac{\partial^2 v}{\partial y^2} = 0$$
 (14)

From equation (5) & (6) we concluded that the real and imaginary parts are u & v of an analytic function f(z) satisfy the Laplace's equation

Hence u & v are known as Harmonic functions.
