
Revenue Recognition Is An Accounting Principle Under Generally Accepted Accounting Principles (GAAP)



<u>REVENUE EXPENDITURE</u>

- **Revenue Expenditure Is An Expenditure Incurred On Fixed Assets In Connection With Their 'Maintenance' Which Are:**
- >Purchase of raw material & goods
- ≻Maintaining of fixed asset.
- >Depreciation of fixed assets.
- >Day to day business activities.
