

Fig. (5). Binding mode of Octadecanoic acid in the active site region of receptor 1JIK (a-3D interaction, b-2D interaction).

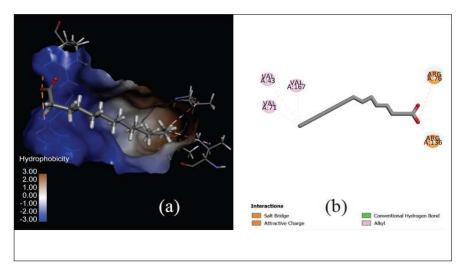


Fig. (6). Binding mode of Tetradecanoic acid int he active site region of receptor 1KZN (a-3D interaction, b-2D interaction).

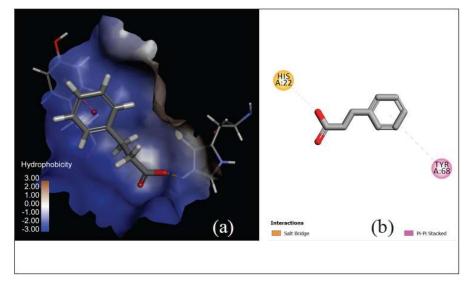


Fig. (7). Binding mode of Hydrocinnamic acid int he active site region of receptor 4JX9 (a-3D interaction, b-2D interaction).
