- Documentation provides both,

## **Good Documentation Practice (GDP)**

"GDP describes the standards by which documentation is created and maintained in the pharmaceutical industries"

- DOCUMENTATION is the process of communicating in written form about essential facts for the maintenance of continuous history of events over a period of time.
- RECORD is the permanent written communication that documents information relevant to a client's health care management
- GUIDELINES is a document that provides recommended practices and instructions
- POLICY is a plan or adopted course or principle of action intended to influence and determine the decisions or actions of an organization

- Document remain legible and readily identifiable
- Documents of external origin identified and their distribution controlled
- Prevent unintended use of obsolete documents, and archiving

## **ESSENTIAL OF GOOD DOCUMENTATION**

- In a GMP Environment, Documentation needs to meet certain requirements to ensure product quality & product safety
- If an instruction or record is poorly documented, then the manufacturer or quality assurance/control of a product can be negatively impacted, potentially reducing patient safety
- The standards of documentation within a company can directly impact the level of success in manufacturing quality products that are safe as well as success during audit situations
- Ensures documentation evidence, traceability, provide records and audit trails for investigation
- > Ensure availability of data for validation, review and statistical analysis
- > Control of Process Ensure all staff to know what to do and when to do
- > To improve performance
- Regulatory requirements

# **CONSTITES GOOD DOCUMENTATION:**

- 1. Clearly Written documentation:
  - > All documents must be accurate & written in manner that prevents error and ensure consistency
- 2. Using indelible ink:
  - > All records must be filled out in indelible ink for long term legibility. Don't use pencil or ink that can be erased
- 3. Legible hand written entries
- 4. Reviewing & approving
- 5. Staff signatures:
  - > Hand written signature must be unique to the individual and listed within the site signature register to ensure that signature is traceable to a member of staff. Staff are not permitted to sign for another member of staff unless delegated
- 6. Page Numbering:
- 7. Concise:
  - > The document must provide clear information that is understood by all customers
- 8. Traceable:
  - ➢ Who recorded it, where and why
- 9. Contemporaneous:

#### CHANGES OR AMENDMENTS ARE MADE IN A COMPLAINT MANNER

## **A. MAKING A LEGIBLE CORRECTION:**

If correction needs to be made, the original record must be still legible

- 1. Make a single line through the error-never use correction fluid, multiple crossmarker pen to obscure the original record
- 2. Provide a brief comment why the change is required
- 3. Initial the change so that it is clear that the correction is deliberated
- 4. Record the date of the correction next to the initials so that there is a record of when the change was

made

## **B. HANDLING OMITTED DATA:**

If an entry was omitted and must be made at a time later than the activity was performed

- 1. Clearly indicate the date the activity was performed and the date the activity is recorded on the documentation
- 2. Document an explanation to substantiate the entry & reason for the delay in recording
- 3. Sign & date the change Back dating of entries is not permitted

## **COMMON DOCUMENTATION ERRORS:**

- Missing signature and dates at the time of activity performed
- The write-over
- Non-uniform date and signature entry
- Writing a note that activity was performed on one day and signed for another day
- Blank spaces'

# DISTRIBUTION RECORDS

## **INTRODUCTION:**

Distribution records are written data related to distribution of drugs from manufacturer to distributors. They are one of the most important records required by GMP regulators. These records should be maintained in such a way that a batch related distribution record is easily available

# **OBJECTIVES:**

The objective of this guidelines is that if there is some adverse drug reaction or some quality defects, the manufacturer should be able to recall the batch of the

drug promptly. The information containing in these records is a key for notification of customers in the event of a product recall.

- Every distributor is also obliged to maintain a complete and accurate record of further distribution
- A distribution register may be maintained for detailed information of each batch of drug product.

**CONTENT OF THE RECORD:** 

- Name

- Date and quantity shipped
- Control number of drug product

**Product Information:** Describe the product being transfer to a new owner (e.g. drug name, manufacturer, lot number, strength, dosage form)

**Transaction Information:** Describe the sale, transfer, return or other disposition of the product (e.g. quality, invoice number, invoice date)

Distribution Information: Describe the party selling or transferring owner ship of the product (e.g. business name, name and signature of person)

**Recipient Information:** Describe the party receiving the product (e.g. business name and address, date received, name and signature of the person)

## **DOCUMENTATION**

Distribution records include a wide range of documentation such as invoices, bills of lading, customer's receipts and internal warehouse storage and inventory records
