5. **Condensation and Collection:** At different levels of the distillation column, trays are designed to allow for the condensation of the vaporized hydrocarbons. The condensed hydrocarbons, now in liquid form, are collected at these various levels, forming different fractions or cuts. Each fraction contains hydrocarbons with similar boiling points.

6. **Cooling:** After collection, the fractions are further cooled to separate any remaining gases or lighter components from the desired products. This cooling process may involve the use of heat exchangers or condensers.

7. **Product Recovery:** The collected fractions are then transported to additional refining processes to obtain specific products. For example, the lighter fractions, such as propane and butane, can be liquefied and stored as liquefied petroleum gas (LPG). The heavier fractions, such as gasoline, kerosene, diesel, and fuel oil, undergo further refining steps to remove impurities and adjust their properties for specific applications.

8. **Residue Treatment:** The residue left at the bottom of the distillation column, known as atmospheric residue or bottoms, contains the heaviest hydrocarbons and impurities. This residue is often further processed through additional refining techniques such as vacuum distillation or other conversion processes to maximize product yield.

By following these steps, fractional distillation separates crude oil into its various components or fractions based on their different boiling points, allowing for the production of a wide range of valuable petroleum products.

Products Obtained:
